CAPTION

A portion of Government Lot 2, lying and being a portion of Section 3, and Section 10, Township 4 South, Range 27 East, City of Jacksonville, Duval County, Florida, being more particularly described as follows: COMMENCE at the Northeast corner of Lot 10, Block 5, Hunters Point at Mandarin Unit Nine, as recorded in Plat Book 39, Pages 57, and 57A, of the current Public Records of Duval County, Florida; thence run North 89°45'33" East, along the North line of the South 1/2 of said Government Lot 2, also being the South line of the lands described and recorded in Official Records Volume 4831, Page 980, (a 50 foot drainage easement for the City of Jacksonville), 1318.79 feet to the Easterly line of said Government Lot 2; thence South 01°07'08" East, along said Easterly line of Government Lot 2, 671.95 feet to the POINT OF BEGINNING; thence continue South 01°07'08" East, along said Easterly line, 673.89 feet to an angle point in said Government Lot 2; thence South 00°23'46" East, along said line, 1273.39 feet to the Northerly right-of-way line of Losco Road (a 60 foot right-of-way as now established); thence South 89°24'50" West, along said Northerly right-of-way line, 285.00 feet; thence North 00°35'10" West, departing from said Northerly right-of-way line, 110.00 feet; thence North 19°55'55" West, 102.98 feet; thence North 28°03'04" West, 350.02 feet to a point situate on a curve leading to the right; thence along and around the arc of the curve, said curve being concave Northwesterly and having a radius of 301.45 feet, an arc length of 3.55 feet, said arc being subtended by a chord bearing and distance of South 61°36'37" West, 3.55 feet to a point of tangency; thence South 61°56'56" West, 83.94 feet; thence North 28°03'04" West, 50.00 feet; thence North 61°56'56" East, 83.94 feet to a point of curvature of a curve leading to the left; thence along and around the arc of the curve, said curve being concave Northwesterly and having a radius of 251.45 feet, an arc length of 3.55 feet, said arc being subtended by a chord bearing and distance of North 61°33'51" East, 3.55 feet to a point situate on said curve; thence North 28°03'04" West, departing from said curve, 99.97 feet; thence North 13°20'03" West, 73.65 feet; thence North 04°08'38" East, 746.81 feet; thence North 35°51'26" East, 206.46 feet; thence North 16°43'15" East, 118.54 feet; thence North 00°14'27" West, 175.00 feet; thence North 89°45'33" East, 15.00 feet; thence North 00°14'27" West, 160.00 feet; thence North 89°45'33" East, 101.17 feet; thence South 01°07'08" East, 84.63 feet; thence North 88°52'52" East, 50.00 feet; thence South 01°07'08" East, 50.71 feet; thence North 88°52'52" East, 175.00 feet to the POINT OF BEGINNING.

ADOPTION AND DEDICATION

This is to certify that D. W. Hutson Construction, Inc., is the lawful owner of the lands described in the caption hereon known as FOXWOOD TRAILS unit FOUR, and has caused the same to be surveyed and subdivided; that FIRST FEDERAL SAVINGS and LOAN ASSOCIATION of JACKSONVILLE, a United States of America Corporation, is the holder of the mortgage on said lands and that this plat made in accordance with said survey, is hereby adopted as a true and correct plat of said lands. All drives, courts, drainage right-of-ways and easements for drainage, utilities and sewers are hereby irrevocably, without reservation, dedicated to the City of Jacksonville, its successors and assigns. The drainage easement through and over the lakes and filtration systems shown on this plat are hereby irrevocably dedicated to the City of Jacksonville, its successors and assigns and are subject to the following covenants which shall run with the land: (1) the drainage easements hereby dedicated shall permit the City of Jacksonville and its successors and assigns to discharge into said lakes and filtration systems which these easements traverse, all water which may fall on or come upon all drives and courts hereby dedicated, together with all soil, nutrients, chemicals and all other substances which may flow or pass from drives and courts, from adjacent land, or from any other source of public waters into or through said lakes and filtration systems without any liability whatsoever on the part of the City of Jacksonville, its successors and assigns for any damages, injuries or losses to persons or property resulting from the acceptance or use of these drainage easements by the City of Jacksonville, its successors and assigns; (2) the lakes and filtration systems shown on this plat are owned in fee simple title by the abutting property owners; and the City of Jacksonville by acceptance of this plat assumes no responsibility for the removal or treatment of aquatic plants and animals, soil, chemicals or any other substance or thing that may even be or come within said lakes or filtration systems which these easements traverse, nor any responsibility for maintenance or preservation of the water purity, water level or water depth which responsibilities shall be those of the abutting owners, and; (3) the City of Jacksonville, its successors and assigns shall not be liable nor responsible for the creation, operation, failure or destruction of any water level control equipment which may be constructed or installed by the developer or any other person within the area of the lands hereby platted or of the lakes and filtration systems shown on this plat, but shall have the right to modify the existence of the lakes and filtration systems and that which retains it, to effect adequate drainage, including, but not limited to, the right to remove any water level control structures or any part thereof. D. W. Hutson Construction, Inc., developer and owner of the lands described and captioned hereon, shall indemnify the City of Jacksonville and save it harmless from suits, actions, damages, liability and expense in connection with loss of life, bodily or personal injury, property damage or other damage arising from or out of any occurrence in, upon, or at, or from the lakes and filtration systems described above, or any part thereof, or occasioned wholly or in part by any act or omission of D. W. Hutson Construction Inc., its agents, contractors, employees, servants, licensees or concessionaires with FOXWOOD TRAILS unit FOUR. This indemnification shall run with the land and the assigns of D. W. Hutson Construction, Inc., and shall be subject to it. The Jacksonville Electric Authority Easements as shown are dedicated to the Jacksonville Electric Authority and its successors for its use in its underground electric distribution system.
